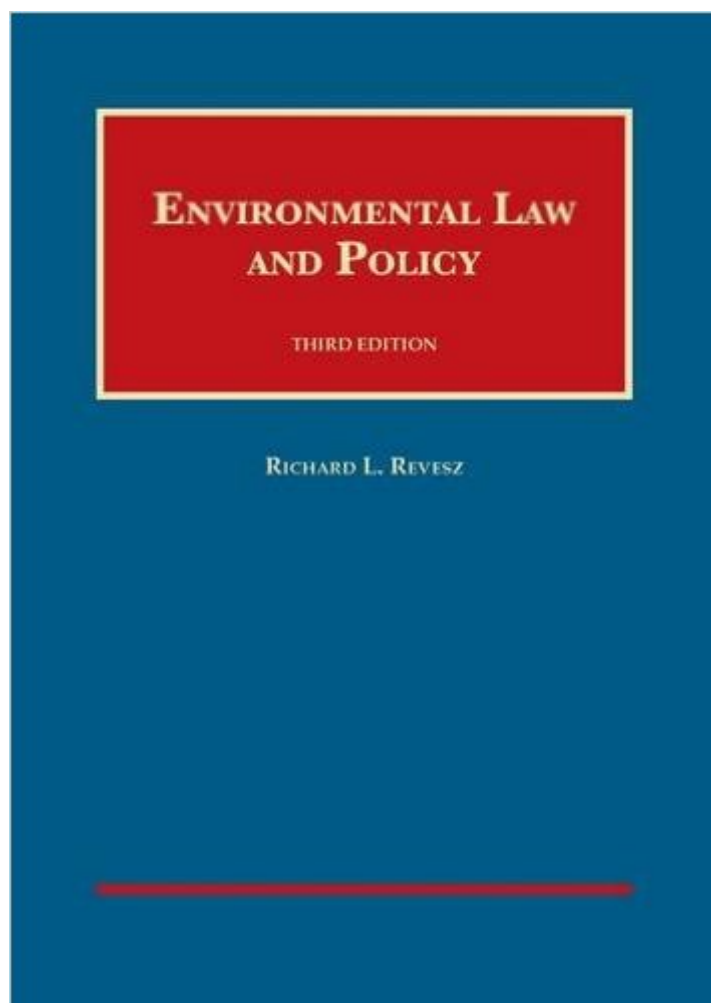

Synopsis

This casebook emphasizes environmental policy, as well as the structure and details of the federal environmental statutes. The book has been updated primarily to underscore the importance of the regulation of greenhouse gases under the Clean Air Act.
