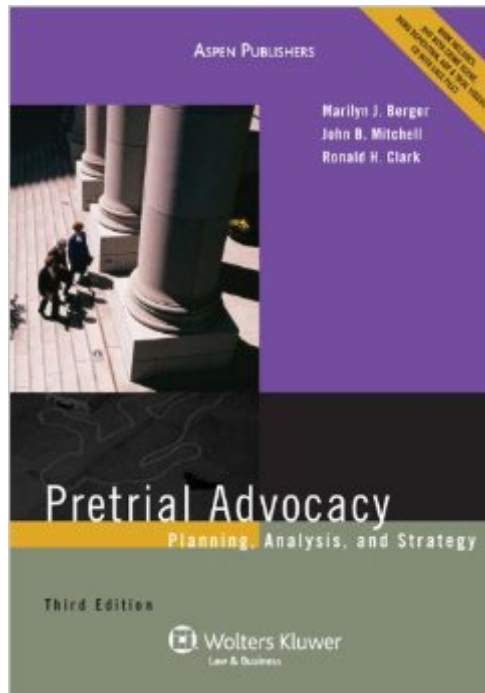

I cannot give it high enough praises. The only drawback for some is the way the book does not exactly follow a linear line and your review chapters of the book multiple times.
